Walton Road

It is proposed to commence work on the Walton Road scheme on 6th March, weather permitting. Paul will be sending out letters to residents at the end of February advising them of the works.

Initially we cannot implement the 20 mph scheme as it is not supported by Thames Valley Police on the basis that there is no evidence to support such a limit. I therefore propose with your/Parish agreement to proceed as planned. We will then monitor speed using SID data and if this shows a justification for a 20, we will go back to TVP with the evidence.

Hopefully this will be regarded as a reasonable approach

Land in the Bow Brickhill triangle bordered by the Bow Brickhill Road, the Bletchley to Bedford railway line and the old Watling Street (with the A5D running through the centre) will be allocated as Employment land in the Plan:MK proposals to be discussed at MKC Cabinet on 21 February

A5130 – once the Fen Street link has been completed, the A5130 will be declassified. Joint working between MKC and Central Bedfordshire is underway with a plan to de-classify the entire length in one go. **The timescale for this is October half term 2017** and part of the work will be look closely at HGV movements with a view to alternative routing. In tandem with the declassification, the opportunity will be taken to look at speed limits (Proposal 19) and the overall condition of the route

The MK Council Cabinet will be going out to consultation for 12 weeks on the contents of the Plan:MK document which will include proposals for the land east of Church Farm etc. as mentioned above.

• Finally, an organisation known as the Hayfield Partnership is on the verge of submitting an application to Central Bedfordshire Council for the first phase (750 dwellings) on land just across the county border at Lower End. L&Q completes the acquisition of Gallagher

Estates

L&Q completed the acquisition of Gallagher Estates on 2 February 2017, one of the largest strategic land companies in the UK, for an enterprise value of approximately £505m.

L&Q is a charitable housing association committed to solving the housing crisis. Land is a key part of the solution.

The acquisition of Gallagher Estates follows L&Q's merger with East Thames Limited, the launch of an ambitious plan to enable the delivery of 100,000 new homes and a £2.6 billion refinancing package which creates the platform for growth.

Gallagher Estates are a strategic land business based in Warwick. They control plots to deliver 42,500 new homes, mainly in the South and South Midlands. The business promotes sites through the planning process, from pre-allocation stage to securing implementable planning consents, before delivering serviced land to the market place. This acquisition places L&Q as one of the leading enablers of new homes across the UK.

Gallagher Estates will become a wholly owned subsidiary of L&Q, and will continue to be run by the current management team as a stand-alone entity.

David Montague, Chief Executive of L&Q said: "Our acquisition of Gallagher Estates is a defining moment for L&Q and shows commitment to our vision of creating 100,000 new homes in our capacity as lead developer and as an enabler working with key delivery partners.

"Through this deal L&Q will unlock land for development across a wider range of tenures, and speed up the delivery of new homes through our ability to invest over the long term.

"It will also add the significant skills and expertise of one of the UK's leading strategic land companies, and allow L&Q to take a lead role in housing delivery on a regional basis, whilst generating significant resources for reinvestment into new affordable housing."

Tony Gallagher, Chairman of Gallagher Estates, said "I am delighted to entrust the business that I have developed over many years to L&Q. They have impressed me at every level throughout this transaction. I have no doubt that they will achieve all their new housing objectives and that they will play a big part in resolving the under-supply of housing for UK Limited. I wish them all the luck in the world for the future."

The acquisition does not include Tony Gallagher's commercial and retail property development and investment activities.

L&Q expects the acquisition to become immediately accretive to L&Q's earnings.



Milton Keynes 50th Birthday

What a great Birthday present as Milton Keynes is highlighted in the UK Powerhouse Q3 report for a GVA increase of 3.0% annually, overtaking Cambridge to take the top spot. This was heavily driven by a strong service sector and healthy business atmosphere, which continue to help production. Milton Keynes was also the strongest performing city in terms of employment growth, expanding employment in line with growth, with a 2.1% annual increase. 
Phil's successor has been agreed and will be announced in the coming days.

There is a special Cabinet Meeting **on 21 February** devoted to *Plan:MK* and the proposed next stage of the plan to go to consultation in early Spring. The big issues are around proposed expansion in the rural north which has received plenty of local press coverage.

- Plan period now 2016 2031
- Hot off the press is a change to the planning period for Plan MK which will now be 15 years instead of 20 years. The impact of this change is to take pressure off housing numbers.





Council Budget

Cabinet have published their revised draft budget, which were presented at the Cabinet discussion on Tuesday 7 February. At that meeting Cabinet approved the draft budget, possibly making a few changes, for submission to Council for discussion at its meeting on 15 February.

The key changes since the initial draft are:

- The additional 1% (£1m) Tax levied for Adult Social Care. This takes the Council Tax increase to 4.95% before increases levied by other precepting authorities.
- For WCC area that will mean an increase on a Band D of c £80-£100 pa, (assuming Parish Council accepts proposals for Parish precept increases).
- The reduction in funding to Parishes who already do their own landscaping has been removed (£120k). This logically should mean that if WCC take on landscaping they will get a grant covering the full cost of the current service?

- Employee parking charge increases of 300% for low emissions and car shares will be spread over 2 years
- Residents parking permit charges halved to £25pa
- More staff for managing temporary accommodation solutions.
- Several one off funds created Waste Strategy possible options, slippage and other problems at the new Residual Waste Facility plant, emergency accommodation.



MK 2050

It has been announced that Sir Peter Gregson will lead the project within MK 2050 for a new university in MK, working with the Open University, Buckingham and University of Bedfordshire. This is a big step forward as it cements Sir Peter in the leadership position.

Oxford - Cambridge (via MK) Expressway



Good signs that this proposed development corridor is gaining traction, with strong mutterings about sponsorship for infrastructure development including the Expressway for which MK expressed its preferred route in December.

A planning moratorium on land east of Church Farm until 2026 is proposed to allow the route of the expressway to be designed – expect an announcement in the autumn 2017 as to a preferred detailed path for the road.

Marston Vale Community Rail Steering Group At its

meeting a few weeks ago there were announced a few timetable changes on the Marston Vale Line (Bletchley to Bedford) to be introduced from the May 2017 timetable change. Attached is the timetable with changes highlighted. London Midland has outlined the reasons/benefits of the changes below.

Monday to Friday:

- Earlier 1st arrival into Bletchley (0653) to connect with 0700 mainline train to Euston. This London bound passengers will arrive Euston at 0739 as opposed to 0806 currently. Also provides a connection to the 0706 Southern to East Croydon.
- 0812, 0912 & 1012 arrivals at Bletchley to provide a connection with the xx17 Southern services to East Croydon. Also it makes the busy 0819 connection to Milton Keynes Central more robust too.
- Retimed 2055 to 2100 from Bedford to coincide with finishing times for evening classes at Bedford College.

Saturday:

- Overall I have tried to have as much of a clockface timetable (trains departing at the same time each hour throughout the day) as possible; we can't achieve as much during the week due to school finish times.
- xx:01 ex Bletchley which is a really good time for connections from Birmingham, London and Clapham will run from 1001 through till 1701. After that we have 1750 and 1847 which still connects with Semi-Fast trains from Euston. In the opposite direction from Bedford trains run at xx55 from 1055 until 1755 (with the exception of a 1700 departure).
- Four AM arrivals at Bletchley (0712, 0812, 0912 & 1012) which connect with the xx17 Southern services to East Croydon.
- Less service gap in the evening. 1h17m as opposed to current 1h30m at Bletchley. Can't reduce anymore due to traincrew breaks.

If you have any questions please let me know. There could be further changes in June, including the introduction of extra morning trains and retiming of one of the trains in this timetable (0731 ex Bletchley). However this is not yet confirmed as it is related to a rolling stock cascade which is still to be decided.

There will of course be public timetables produced but this is an early warning. You may want to publicise what I hope will be generally positive changes.



The Greensand Trust has secured £3.1 million to reverse the decline in the character of the Greensand Country landscape. We would like you to become involved.

Bedfordshire Rural Communities Council (BRCC) and the Greensand Trust are thrilled to have gained funding from the Heritage Lottery Fund to deliver a Landscape Partnership programme and an array of exciting projects which will help us raise awareness of the hidden heritage of the Greensand Country and to reverse the gradual decline in the distinct character of this beautiful and loved landscape.

'Greensand Country' is an island of distinctive, beautiful and loved countryside, based on a band of higher ground stretching from Leighton Buzzard to Gamlingay, rising out of the surrounding clay vales. It contains all of Bedfordshire's remaining heathland, more than half of its woodland, and more surviving historic parkland than any other landscape in the country, often surrounding notable manor houses. This landscape character is a legacy of its underlying Greensand geology, which led to much of it being regarded as 'marginal land' not suitable for agriculture, as well as its management over centuries by major estates

However, the landscape's very distinctive character has been weakening over decades due to modern development and changes in land use. Valuable habitats are becoming fragmented; views of and from the area are being lost or impaired; houses are being built of the wrong character and traditional heritage skills are dying out. Just as significantly, there is a low level of understanding locally of the importance of the area's landscape value and heritage.

The Greensand Country Landscape Partnership has been formed by a range of partners in the area who will work with landowners and local communities to take a joined up approach to meeting the challenges in the area.
