

## LOOKING TO THE **FUTURE**

Recent expansion and other planning issues have rather dominated The Parish Council in recent months, and we had become rather reactive rather than proactive. We

are now starting to work on a series of priorities, namely to.

- Improve the natural and built environment of the whole Parish
- Support and maintain community facilities and services within the Parish
- Deliver the types of development which meet 3. the needs of the community
- Limit the impact of traffic and to encourage sustainable transport

Crime is a priority concern for residents. The Wavendon area has a low crime rate and is a safe place to live and residents wish this to be maintained.

Our priority is to ensure that all development will endeavour to not only be 'Different by Design' but to also 'Design out Crime' by applying the principles of Secure by Design. Responsibility for ensuring that these principles are applied sits with Milton Keynes Council as the local Planning Authority and WPC lobbies at every opportunity to ensure MKC sticks to these basic principles in all applications.

WPC further commits to review all planning applications in line with the national and local planning policies and to submit comments to support robust approaches to Secure by Design principles in all aspects of development.

#### We will also priorities the provision of;

- Play Areas & Allotments
- High quality Broadband provision in all areas
- Street tree planting and hedgerow retention
- Installation of Defibrillators across the Parish
- Outdoor open space provision with outdoor gym equipment (fitness trails)
- Improve the quality of public realm (lighting, footpaths, seating, bollards)
- solutions that address the importance of being able to get around easily and safely (especially to our new schools and community hubs) whether travelling by vehicle, bicycle or on foot
- measures that reduce congestion at identified trouble spots across the Parish. Promote 20 MPH and Low Traffic Neighbourhood areas as appropriate and where resident's demand
- Community Hubs liaising with local service providers, including GPs, and developers to influence service and retail provision
- The provision of public art and Tommy (memorial) Statues as appropriate

# Wavendon & Woburn Sands residents warned about scam texts for NHS COVID-19 passes

The Chartered Trading Standards Institute (CTSI) has been sent evidence of a recent text scam themed around the NHS COVID pass. The message, which claims to be an official communication from the



National Health Service (NHS), reads: "NHS: We've noticed you haven't applied for your COVID pass, please follow the link to complete registration to avoid fees...".

The message then links to a website made to look like a real NHS platform that asks the recipient to provide personal details, supposedly for registration purposes, but which could be used to undertake identity fraud.

Speaking about the scam, CTSI Chief Executive John Herriman said: "Since the first COVID-19 lockdown in March 2020, CTSI has witnessed countless scams themed around the pandemic. CTSI Lead Officer, Katherine Hart, added: "The public should apply for an NHS COVID Pass or vaccination certificates on the official platforms, which are different, depending on if they are resident in England, Scotland, Wales, or Northern Ireland".

"Whenever we receive these messages, we should not only avoid these scams, but also report them to Action Fraud. By reporting scams, authorities can build a fuller picture of this dangerous fraud blighting communities throughout the United Kingdom."

# **Annual Canvass Reminder**

MK Council is now in the second stage, with the delivery of around 100,000 canvass forms to households across MK, so if you did not receive an email expect to receive a letter from us in the coming weeks.

Nearly 20,000 households won't receive a form, having already responded to an email prompt earlier in the month.

Please ensure you check the forms and respond where required as soon as you can. Canvassers may telephone or call at your property where no response has been received if required from September till October.

## WHAT IS THE ANNUAL CANVASS OF THE **ELECTORAL REGISTER**

Emails and canvass forms are sent to every household giving details of what information is currently held on the Electoral Register at that property. Occupiers are required to check the information and confirm that it is correct or make any changes that are necessary so that a revised register can be published on 1 December. Different forms are sent to all residential properties during the canvass, please check the form carefully and respond as soon as you can only if it requires you to do so.

Please respond as soon as possible so your details can be updated.


Glebe Farm is located 2.6 miles from junction 13 of the M1 in Milton Keynes.

They're community initiatives owned and run by their members which are supported by the police but not owned by them, although we sometimes run them. They work by developing a close relationship between community members and the local police.

- •help and reassure those who live in the area
- encourage neighbourliness and closer communities

The Community Speedwatch scheme is set to provide communities with equipment and training to monitor speeding in their area.

Thanks to a new partnership with Community Speedwatch UK, a not-for-profit social enterprise that provides support for speedwatch schemes, Thames Valley will be taking a major step forward in the fight to improve road safety.

Organised by the Office of the Police & Crime Commissioner, speedwatch groups will be provided with a starter kit on a loan basis, including a speed detection device, to help volunteers to assist in the battle against speeding motorists.

Before community teams can be deployed to the roadside, they will undergo a number of training sessions both online and at the roadside and ensure risk assessments have been completed.

The new online platform allows group-related activities to be self-regulated via an online calendar and also provides vehicle make recognition training. DVLA pre-checks logged registration numbers for authenticity before automatically passing data on to the police for further processing. Existing Community Speedwatch groups will be contact directly about restarting activity once coronavirus restrictions allow.

A six month trial will take place in pre-selected locations in order to test the new online platform and get feedback from volunteers. If successful the new scheme, including the loan of equipment will be rolled out to new and existing groups towards the end of 2021.

# Milton Keynes Mayor visits new **Wavendon Community Library**



Cllr Mohamed Khan (The Mayor of Milton Keynes) dropped in to Wavendon on Wednesday 16 June to inspect the new Community Library facility based in the extended Wavendon Community Centre off Walton Road.

He was hosted during his visit by Wavendon Parish Council Chairman, Cllr David Hopkins as he inspected the fully stocked shelves in the Library Section of the former village Primary School (the school building having been transferred to Wavendon Parish Council in 2020 as an extension of its community centre facilities).

The books have mainly been supplied by Milton Keynes Council Library Service and consists of stock no longer required at the Borough's main Libraries. Residents will be able to call into the centre and take out (and keep if they so require) books from the stock and donate books to the facility no longer required by residents.

Cllr Hopkins commented 'we are very grateful to MK Council for the way in which it has worked with our Parish Council in both securing the transfer of former school building and in supplying the Parish with so many books (of all types and which will appeal to all ages) to make this community initiative a reality.

The pandemic has obviously delayed opening the facility, but Wavendon Parish Council hopes the community library will be open to residents from September this year.

# Silverware for **Wavendon**

In a hugely COVID disrupted football season, a highlight for WWFC has been the achievements of the Under 16 Hurricanes team.

Having played most of their home matches at Wavendon Recreation Ground since the team was formed in 2011, it's been years of near misses and occasional runners up. This season not only saw the team lift the Milton Keynes & District Development Under 16 League title, they also progressed to the quarter finals of the County Cup and the latter stages of the League Cup before COVID saw both competitions cancelled. # Do you have working smoke alarms?

In 1987, only 9 per cent of households in the UK had a working smoke alarm. Roll forward to today, and current figures indicate about 90 per cent of households now have a working smoke alarm. However, in some instances, smoke alarms are not fitted in the right place, or are not suitable for the occupiers needs.

Correctly installed working smoke alarms can help prevent injury and minimise damage in the event of a fire in the home. It is crucial that any outbreak of fire in the home is quickly detected, with the alarm raised at the earliest possible stage of smoke production and fire growth.

Buckinghamshire Fire & Rescue Service believes every home should have smoke alarms and no home should be unprotected.



## **SMOKE ALARMS**

- Smoke alarms are cheap and easy to install
- they are available from DIY stores, electrical shops and most high street supermarkets.
- Fit a smoke alarm on every floor of your home.
- Smoke alarms should be located in a circulation space such as a hall or landing as a minimum.
- Additionally, smoke alarms should be fitted in every room in the house which is regularly inhabited.
- Heat alarms could also be fitted in the kitchen, and where possible interlinked with the smoke detectors.
- All smoke alarms (including hard wired or those with removable batteries) should be replaced after ten years, or by the 'replace by' date indicated on the base.
- Check all your alarms regularly (at least monthly!). If one is found to be defective, don't wait for the ten-year lifespan to end - replace it immediately!

# **Seasonal Safety Advice -Check Your Chimney!**

As the summer draws to a close and we prepare for colder evenings, Buckinghamshire Fire & Rescue Service is urging people who have open fires or stoves to take care.

Please ensure your chimney is in good condition and is regularly swept.

A blocked or defective chimney can cause carbon monoxide poisoning as well as a fire. So regular inspection and cleaning of chimney flues can help to identify and eliminate issues before they become a problem.

Make sure your chimney is swept regularly by a certified chimney sweep. The recommended frequencies depend upon the fuel you burn.



## A QUICK GUIDE

#### recommended frequencies are:

- Smokeless coal at least once a year
- Wood up to four times a year
- Bituminous coal twice a year
- Oil or gas once a year (refer to the Gas Safe Register for gas)

It is also important to have working smoke alarms in your home and that you test them once a month. If you are using an open fire or stove it is also advisable to invest in a carbon monoxide detector, as early warning can make the difference.



## **SAFE CHIMNEY USE**

- Always use a fire guard to protect against flying sparks from hot embers.
- Make sure embers are properly put out before you go to bed.
- Keep chimneys and flues clean and well maintained.
- If you have recently opened up, or are about to start to use a fireplace, make sure it is inspected by a qualified person.
- When burning wood, use dry, seasoned woods only.
- Never burn cardboard boxes or paper.
- Inspect your chimney breast, particularly in the roof space.
- Make sure that the chimney breast is sound, and that sparks or fumes cannot escape through cracks or broken bricks.
- Ensure wood burners are installed and maintained in accordance with the manufacturer's instructions.
- Make sure the appliance receives enough air to allow the fuel to burn properly.
- Consider fitting a carbon monoxide detector.





#### Carbon monoxide

Carbon monoxide (CO) is a poisonous gas that has no taste or smell. Breathing it in can make you unwell, and it can kill if you are exposed to high levels. The main symptoms are headaches, nausea, breathlessness, collapse, loss of consciousness and dizziness.

Incorrectly installed, poorly maintained or poorly ventilated cookers/heaters/boilers/fireplaces common causes of accidental exposure to CO. Make sure they are properly maintained and serviced, and chimneys are regularly swept, and install a CO detector in your home.

# **Construction begins in** Wavendon for new £3.5m **Sports Complex**



Milton Keynes Council, working with Wavendon Parish Council marked the start of the construction of a new £3.5m sports complex to serve new developments in the growing Parish of Wavendon and neighbouring areas. Facilities will include a community pavilion with a multi-purpose hall, team changing rooms and café, as well as five new football pitches constructed to Sport England standards. Funding for the project has come from money collected from the developers who are building housing in the 'Strategic Land Allocation' to the east of MK, mostly in Wavendon.

Once built, the new development will be managed and maintained by Wavendon Parish Council and will be the future home ground of Woburn and Wavendon Lions Football Club. The fields and pavilion will also be available to local people and groups. Cllr David Hopkins (Chairman of Wavendon Parish Council) and Cllr Robert Hill (Vice Chairman of Wavendon Parish Council and Chairman of Woburn and Wavendon Lions) have led in the in the project that is being managed by the Sports, Leisure and Communities and Urban Design Landscape Architecture at MK Council. Cllr Hopkins and Cllr Hill were joined onsite by Mayor Mohammed Khan and members of the project team from MK Council as the first stage of construction began earlier last week.



## Exciting new £3.5m facilities to support our growing community

## 1. Wavendon Heights **Playing Fields**

Work is now well under way to deliver the new playing fields and public recreation space at the new Wavendon



Heights site between Stockwell Lane and Newport Road, Initial work has concentrated on "cut and fill" work that has seen significant earth moving which has now delivered a northern and a southern area of level ground capable of supporting five football pitches for various age groups. The next stages will involve vital drainage work that will enable use during wetter months. The sloping nature of the site has made this a challenging proposition, however progress has been good and it is still anticipated that the Sport England standard pitches will be available for use in September 2022. That date does rely upon favourable weather conditions, not only for the work currently being undertaken, but also for the eventual germination and development of the specially selected seeded grass surfaces. Of course the site is not just about playing fields. There is a significant area devoted to general public recreation, with walks, ponds and viewing areas. It is also hoped to develop areas for wildlife, as well as the planting of a significant number of trees.



# 2. Wavendon Community Hub Close on the heels of the new

playing fields will be the building of the new the Wavendon Community Hub. The attractive pitch roofed brick built structure

will provide a large 160 sq. metre hall, as well as other community focused facilities (kitchen, bar/café and storage) to support and encourage community integration and participation. With parking available for 110 vehicles, the Hub will be able to cater for large gatherings, and will complement the facilities available at the existing and recently expanded Wavendon Community Centre on Walton Road. It

will also provide changing facilities and storage for the adjacent playing fields. Anticipated completion is also September 2022.

With such significant increases in population, it's vital that Wavendon has adequate facilities and outside spaces in order to encourage, health, wellbeing and community integration. Both the Hub and Wavendon Heights are the first elements of supporting a vibrant and growing Wavendon. Your Parish Council is actively working to access and safeguard additional open spaces for community use.

On 23 July, Central Bedfordshire Council adopted its Local Plan 2015 -2035, following receipt of the Planning Inspectors' Final Report.

Thankfully, at least for the next few years, the so called Aspley Guise triangle - which is land to the east of Lower End ,Wavendon and close to Eagle Farm South - was not included for development. However, this may be a brief respite as CBC are required to undertake an early review of their plan which may them forced to include this land in a very years time. This removes the need to push through an 80 meter wide corridor for a road linking to J13 of the M1 which would have cut through Newport Road in Wavendon and then on through Cross End and Lower End. In effect, the Expressway in any other name.

Given this welcome respite, Wavendon Parish Council will be campaigning for no additional housing in the forthcoming review of the MK Local Plan (Plan MK:2) to be bolted on to the yet to be agreed South East Milton Keynes expansion area. Enough is enough, we need to look forward to a planning holiday. Local roads and other services cannot cope with all this development traffic yet alone the impacts of thousands more dwellings on our infrastructures.

Wavendon Parish Council is also calling on MK Council to liaise closely with the East West Rail Project. Both recent 'consultations' (the SEMK from MK Council and the EWR consultation from the EWR Company) showed clearly a total lack of coordination and cooperation between the two organisations. This has to be addressed.



The latest we have from East West Rai is that a decision on a preferred route from Bedford to Cambridge will be announced by December and then a further (Statutory) Consultation regarding the route from Bletchley to Cambridge will take place late in 2022. This leaves people 'hanging' with enormous stress caused by the uncertainty over proposed compulsory purchase of land and the possible loss of our much cherished allotments and Edgwick Farm land in Woburn Sands.

Wavendon Parish Council has opposed the ill conceived, so called by pass and new railway bridge crossing starting close to the Wavendon Arms (off Newport Road) and running past much of Woburn Sands only to emerge on Bow Brickhill Road and/or Hardwick Road.

More than 190,000 individual comments were made during the 10-week East West Rail consultation.

The public consultation covered two key themes of customer experience and railway operations, and infrastructure proposals. Analysis of the responses is now being carried out. East West Rail says it is categorising comments for review by the relevant teams to ensure that every comment counts.

#### The consultation in numbers:

- More than 9,800 responses to the public consultation;
- More than 190,000 individual comments being analysed;
- 270,000 consultation summaries posted to residents and businesses along the East West Rail route;
- 75,000 documents downloaded from the East West Rail website:
- 51,000 visitors to the East West Rail website and 199,000 page views;
- 4,800 visits to virtual consultation rooms;
- More than 3,500 direct emails with people who asked questions during the consultation;
- More than 400 pieces of media coverage about the
- More than 300 advertisements in media along the
- 64 online meetings with local MPs, councillors and parishes;
- 32 online meetings with stakeholders including industry and business groups;
- 18 online public webinars;
- 16 live chat events.

Simon Blanchflower CBE, chief executive of East West Railway Company, said: "The number of responses we've received, the breadth of information and level of detail they contain demonstrates the value of consulting with local people at an early stage, and the huge level of public interest in East West Rail.

East West Rail Co will publish a report summarising the consultation feedback as well as information on how the feedback has been used to inform plans for the railway.

People will then have further opportunities to comment on the proposals at the statutory consultation, which is planned for late 2022.

East West Rail Co then expects to submit a formal application for a Development Consent Order to the Secretary of State for permission to construct and operate the railway.

East West Rail will create a new direct connection between Oxford and Cambridge. Serving communities across the area, it will bring faster journey times and lower transport costs as well as easing pressure on local roads.

# East West Rail is being delivered in three Connection

- Connection Stage One: Oxford to Bletchley and Milton Keynes
- Connection Stage Two: Oxford to Bedford
- Connection Stage Three: Oxford to Cambridge

Network Rail was responsible for developing the first part of the East West Rail, connecting Oxford with Bicester, and is a partner in a construction alliance to deliver Connection Stage 1 of the project, where East West Railway Company (EWR Co) and Network Rail are acting as the Department for Transport's joint sponsors.

EWR Co is now developing the route to enable services to run to Cambridge via Bedford and will be seeking statutory powers under the Planning Act 2008, following a period of extensive consultation.

# **Broadband Update**

#### **WOBURN SANDS**

The BDUK superfast rollout with BT to various parts of Woburn Sands is now complete. Most of the town can now receive at least superfast speeds or 30 - 80 Mbps with some of the later areas to be enabled with full fibre now able to obtain speeds of 1 Gbps. City Fibre has no current plans to extend its Milton Keynes rollout to the town.

#### **WAVENDON**

Wavendon is included in the procurement area for the Government's BDUK "Project Gigabit" programme. The Project Gigabit procurement area in our part of the country covers around 88,000 premises across large parts of Central Bedfordshire, Milton Keynes and Northamptonshire. MK Council won't know the detail of what's planned to be delivered until the procurement process is complete next year but we expect the deployment to start towards the end of 2022 or early 2023.

The council will aim to provide a further update on what to expect from Project Gigabit in Wavendon and when that is likely to be delivered once the procurement process has been completed.

# Heritage Open Days return

The popular Heritage Open Days take place across ten days this September. This year's packed programme of more than 150 free cultural activities includes guided walks, historic talks, workshops, craft events, open days, exhibitions and performances. Activities are happening at iconic cultural

# **Cranfield University & Marshall of Cambridge**



have announced that they have signed an option agreement for the potential relocation of Marshall Aerospace and Defence Group (MADG) to Cranfield Airport.

The agreement follows extensive talks between both organisations, following the announcement in May 2019 of Cranfield as one of the preferred sites for the relocation of MADG from its current site at Cambridge Airport.

The agreement, which would enable MADG to complete its proposed move by 2030 as planned, provides the company with the right to take a 150year lease on the University's proposed Air Park development, which was granted outline planning permission by Central Bedfordshire Council in April 2018.

It is also interesting to note that in December 2018, Cranfield Airport became the first airport in the UK to operate a digital air traffic control centre. The airport was also recently the location for the world's first hydrogen-powered, commercial-scale aircraft.


