Report from your local December 2025

Focus on the local plan and moving towards the Planning Inspectors enquiry in the spring.

I, along with the town clerk, attended a NALC Planning Seminar in Aylesbury on 24 November focusing on local plans and the Bucks Local Plan and the MK Local Plan, MK2050 in particular. The seminar was titled Futureproof Planning, and the slide set will be circulated to fellow councillors separately.

However, headlines from the event

Expect an announcement from government on its changes to NPPF (National Planning Policy Framework) on 19 December. Major changes expected

- Restrictions on additional 'evidence' presented at planning appeals
- Neighbourhood Plans would be valid for only 5 years (currently 10)
- Changes to National Development management Policies. Unlike the broader National
 Planning Policy Framework (NPPF), which guides plan-making and decision-taking, NDMPs
 are intended to directly influence planning decisions by overriding local policies where there
 is a conflict.
- The Secretary of State will 'call in' any planning decisions for sites with over 150 dwellings
- Parishes will no longer be considered as statutory consultees
- New combined authorities being promoted
- Housing delivery is currently at a 10-year low
- MK has a 7.31-year land supply (min acceptable is 5 years) but Bucks varies from area to area from 3.62 years to 0.75 years in south of the county.

What we don't know

- The role of 'community engagement' moving forward
- What will be the revised 'Neighbourhood Priority Statements' these are supposed to be focused mainly on local issues, priorities and ideas drawn from forms of thorough survey and not move on at that stage to what initiative might be best to deliver on those priorities

 The status of climate change as it seems that Environment Outcome Reports will replace Strategic Environment Assessments. This means a developer simply pays a sum in compensation or creates an alternative environment to replace areas destroyed in development. Whilst the government always sites bats or spiders etc this also applies to dormice and badgers!

So

- Is it a system in turmoil
- Is the government attempting to achieve more from less
- Does the government, as it appears, view parishes as 'blockers'?
- And therefore, town and parish councils are being driven to lead on behalf of their respective communities

Conclusions

- A move towards multi parish neighbourhood plans and joint neighbourhood spatial strategies, scenario planning and the use of professional specialist consultants.
- Local Plans do not think spatially, strategic planning councils choose the least worse options in its planning decision
- The Government has now published new planning practice guidance (PPG) on Green Belt land which outlines the steps to be taken by Local Planning Authorities (LPAs) in assessing Green Belt land to identify grey belt, assessing development proposals on grey belt land and the Golden Rules (specifically accessibility to green space).
- Town and Parish Councils must make themselves aware of their rights under Rule 6 status. An Inquiry procedure also enables interested parties to apply for 'Rule 6' status. This means that parishes can actively engage in the inquiry process and will provide a Statement of Case, proofs of evidence and cross examine at the inquiry.
- Government also views 'nature' as a blocker to planning. However, the Planning and Infrastructure Bill look at establishing the Nature Restoration Fund and thereby create the opportunity for housing and infrastructure to do more for environmental recovery.
- Under the mitigation hierarchy the developer pays money to natural England with which they would acquire alternative sites for displaced nature elsewhere. But there will be the loss of specific habitats. However, it is claimed that developers actually prefer to retain green spaces as they add to the value of the built environment. A new Nature Bill is due in 2026.

- National research reveals that only *53% of green features are ever delivered in the finished developments

Note: The seminar also heard that it was both lawful and encouraged for parishes to use s106 monies for the preparation of Neighbourhood Plans.

What can the s106 Receipts can be spent on by town and parish councils?

Regulations state that this proportion of funds must be used 'to support the development of the local area by funding

- (a) The provision, improvement, replacement, operation or maintenance of infrastructure; or
- (b) Anything else that is concerned with addressing the demands that development places on an area.'

This gives Parish and Town Councils considerable freedom to spend their proportion of s106 on things that address the impacts of developments on the area.

Examples include:

- Improvements to village halls, playparks, footpaths, streetlights etc.
- Preparation of a Neighbourhood Development Plan (providing it addresses the demands that development places on the area)
- Planning Application Fees monies can be used towards a planning application fee that relates to community proposals

Other Matters

- A Strong and Robust Economy I attended a Scrutiny Meeting at which MKCC members were briefed on the state of the local economy The Milton Keynes economy is the seventh largest city economy in England worth over £16.7bn, home to over 12,500 businesses, 200,000 jobs and is already larger in size than Cardiff's economy. Productivity in Milton Keynes is 25% above national levels, and the economy is performing well locally.
- Creative and Cultural Strategy 2027 2035 Strategic Priorities I also attended the scrutiny
 meeting examining the developing MKCC Cultural Strategy. Milton Keynes has evolved
 significantly since the previous cultural strategy was adopted in 2017, with substantial changes in
 population, demographics, economic conditions, and cultural participation patterns. The new
 strategy therefore seeks to ensure that Milton Keynes continues to grow as a vibrant, inclusive,
 creative city that supports innovation, strengthens local identity, and maximises cultural and
 creative opportunities for all residents
 - Sports Strategy 2025-30 I also attended the launch of the MKCC Sports Strategy.
 - SGS I have also met with Richard Bryce, Sports Ground Services regarding the costs of recovering the cricket table in the recreation ground to a safe, playable condition for use by the new Wavendon Cricket Club.

 Centre, Newport Road, Wavendon, Milton Keynes, MK17 8UF Further to undertaking our
 investigation in line with the Local Enforcement Plan (LEP), I write to inform you that we
 closed the case on 28/11/2025 for the following reason.... A site visit was conducted to
 assess compliance with the approved landscaping plan for the ongoing development. It was

observed that several trees, shrubs, and bushes had failed at the site. Following this observation, MKCC Landscape Officer was requested to attend the site to determine whether any Tree Preservation Order (TPO) trees were affected or if there were any breaches of planning control. The Landscape Officer attended the site with the approved landscaping plan for the development. Upon inspection, it was confirmed that the trees which had been removed were shown on the approved plans. The officer also engaged in discussions with the contractors and the site owner, who confirmed that the landscaping works are part of an ongoing project and that replanting will be carried out in accordance with the approved scheme. No breaches of planning control or conditions attached to the approved application were identified during this visit.

- I have been in conversation with officers at the Bucks and MK Fire Authority regarding Fire Prevention in the Danesborough & Wavendon Woods (Greensand Ridge) and the suggestion of a possible joint exercise with Bedfordshire Fire in 2026.
- I have been in conversation with Bedforf to Bletchley Rail Users Association regarding East West Rail and the future of the station at Woburn Sands and a new Woodleys Farm bridge
- Highways Gully Cleaning

This was the response provided to the enquiry by MK City Council:

MKCC apparently follow a risk-based approach to gully cleansing. This is in line with its Codes of Practice which sets out how it will carry out the maintenance of its 75,000+ gullies and drainage infrastructure. They maintain that as they can't do everything, they use a method of prioritising maintenance actions so that areas with recorded flooding issues are done more frequently.

MKCC apparently assess requests for gully cleaning based on flood risk; photographic evidence or site visits; when we last visited or if there is a planned visit; last recorded silt level. After this assessment has been made, the enquiry will be either Critical, High, Moderate or Low Risk.

Critical areas: they report will be visited twice a year to make sure all the roadside gullies are working to capacity.

High Risk: will be done once every two years.

Medium Risk: will be done every four years.

Low Risk: we will attend once within a six-year period.

The councils gully tanker is in constant use and so if it attends a site as part of its cleaning programme and cannot access the gully due to parked vehicles, it is likely that we will be unable to attend again until the next planned cleaning date.





the road roundels along Newport Road have been

removed by Ringway. However, the imprint of the 40 remains! Residents still ask why there cannot be 30 MPH repeater signs installed and the official explanation is 'in the UK, you generally do not see 30 mph repeater signs in areas with streetlights because the streetlights themselves (3 or more lamps, under 200 yards apart) automatically define the limit as 30 mph, making repeaters redundant unless a Traffic Regulation Order (TRO) is in place for exceptions (like a 20 mph zone or if lights are off). A proper 30 mph limit is set by the lights; if a road with lights isn't 30 mph (e.g., 40 mph), then those limits require repeaters'.

Noise issues alongside the A421 and M1 – Eagle Farm South and Glebe farm. Environmental Health advise as follows ...there are two aspects to the noise issue.

1. Did a new or altered road increase levels beyond the statutory limits in the Noise Insulation Regs to existing properties?

2. Do new properties built next to the road suffer from noise levels exceeding the planning conditions or planning policy guidance?

For 1.

Noise Insulation Regulations (Roads)

- Primary legislation: Noise Insulation Regulations 1975 (amended 1988).
- Purpose: To protect residents living near new or significantly altered roads from excessive traffic noise.
- Key criteria for eligibility:
- o The property must be within 300 metres of the new or altered road.
- o Predicted or measured noise level at the building façade must exceed 68 dB LA10 (18-hour) after the road opens.
- o Noise must increase by at least 1 dB due to the new or altered road.
- Mitigation measures provided:
- o Double glazing for habitable rooms.
- o Acoustic ventilation systems (to allow windows to remain closed).
- These measures are usually free to the property owner if the criteria are met.

Typically, the impact expected by new roads is determined by noise modelling and highways authorities will use mitigation like barriers or mounds or road surface specification to ensure no acoustic treatment of existing houses is required. These mitigations also have the benefit of reducing levels outside relevant properties . Gardens etc. (The acoustic double glazing required is not something I'd want in my property as it involves a substantial air gap between glass panes and a mechanical acoustic treated ventilation system)

MKDC used to have a team doing this assessment re the grid roads and new development.

To see if there may be a problem the obvious thing to do would be to set up an environmental noise meter in accordance with the requirements of the regulations for a five or seven day period at the property nearest to the road. (NB the Level may increase with height so if flats are involved it may need a noise meter on a balcony). If levels are above then this would support lobbying of the Highways authority for a proper assessment.

Other issues. The road scheme may have required an environmental statement (inc. noise and pollution?) under the Planning Act 2008. The Environmental Noise (England) Regulations 2006 Requires: Noise mapping and Noise Action Plans for major roads. Identification of Noise Important Areas (NIAs) where mitigation is prioritized. These plans guide long-term strategies for reducing transport noise. They were published in 2022 – see gov.uk and may give an insight into areas of concern and there similarity

For 2

National Planning Policy Framework (NPPF) and Noise Policy Statement for England (NPSE):

- Planning decisions must avoid significant adverse impacts on health and quality of life.
- Developers must mitigate and reduce noise impacts through design and layout.

Local authorities often require:

- Noise Impact Assessments for developments near major roads.
- Compliance with BS 8233 (guidance on internal noise levels).
- Use of ProPG: Planning & Noise for residential schemes.

- BS 8233
- Provides specific internal noise level targets, e.g.:
- o Bedrooms: 30 dB LAeq,8h (night)
- o Living rooms: 35 dB LAeq,16h (day)
- o Gardens: 50–55 dB LAeq,16h (day)
- Historically based on WHO 1999 guidelines.
- Emphasis on technical design measures (façade insulation, glazing, ventilation).

- Introduces a two-stage process:
- Initial Noise Risk Assessment (categorizes site risk based on external LAeq levels).
- 2. Acoustic Design Statement (ADS) demonstrating mitigation and good design.
- Promotes passive measures first (site layout, orientation, barriers) before relying on insulation.
- Key principle: Achieve internal targets with windows open where possible.

Whether any of the above applies depends on if it was conditioned by planning. I'm out of touch with this process. Gillian Clark in Environment Health may be able to help. But the standards could be used to show a problem.

Showing an air quality impact is likely to be more of a problem as the Council has been monitoring for years including in areas which would be expected to be at most risk and as far as I'm aware has not identified a problem in MK. Contact Nicola Adshead in the environmental protection team for more info.

The way forward.

- You could explore with Gillian Clark in Env Health if she could allow some monitoring to be done in the area using MKCC noise kit. She is the Council noise expert. Or use it as a training exercise for one of her team. Capacity might be an issue.
- The OU used to have a strong acoustics capability and may be persuaded to help.
- The Institute of Acoustics is situated in CMK
- ANV a supplier of noise kit is located in Knowlhill MK

Other than that, it is seeing how much a local consultancy would charge – here's a report I found at random as an example.


















If you or someone you know has been diagnosed with a terminal illness, MK City Council can help

Don't forget we are now in the Regulation 19 consultation phase for the **Milton Keynes City Plan 2050**. At this stage, MK City Council is asking for comments on whether the plan is legally compliant, based on strong evidence, and consistent with national planning policy.

This plan sets out how Milton Keynes can grow in a way that delivers new homes, attracts investment and creates well-connected communities. It focuses on making sure people have access to schools, health services, shops and green spaces, while protecting the environment and putting infrastructure in place from the start.

Since 2023, MKCC has run a wide-ranging engagement programme, including events across the city and an online campaign. Around 7,000 comments were received, and your feedback has helped shape the policies now included in the plan.

Before we submit the plan to government for independent examination, we're asking for comments specifically on its legal soundness and alignment with national planning policy.

If you'd like to share your views or suggest changes to help ensure the plan meets national requirements, you can do so **until 22 December at 5:30pm**.

The Centre for Ageing Better picks out the policies likely to have the biggest impact on older people and the work they do at Ageing Better.

The Chancellor has announced tax increases totalling £26 billion in the face of forecasts of weaker economic growth, faster inflation and higher unemployment.

The budget announcement follows weeks of frenzied speculation as to what the Chancellor might announce with up to 13 potential tax policies mooted in the weeks before today's official unveiling in Parliament. The policies confirmed during the Chancellor's Speech in the Commons and official Budget papers include:

- A £150 cut to the average household energy bill from April next year as the government removes a large proportion of energy efficiency subsidies off electricity bills and scraps the energy company obligation (ECO) scheme.
- The government will provide an additional £1.5 billion capital investment to tackle fuel poverty through its warm homes plan.
- The freeze on the thresholds for when people start paying different levels of income tax has been extended and will result in 1.7 million people paying more tax. But the government has said that pensioners whose sole income is the basic or new State Pension will not have to pay the tax due when the state pension rises above the £12,570 threshold for paying 20% income tax.
- Basic and new state pension payments will go up by 4.8% from April, more than the current rate of inflation, under the triple lock.
- More than £800 million in funding over the next three years announced as part of the government's Youth Guarantee which gives every young person a place in college, an apprenticeship or personalised job support.
- Training for apprentices is to be free for under 25-year-olds at small and medium-sized companies as part of the programme.
- Salary-sacrificed pension contributions above an annual £2,000 threshold will no longer be exempt from national insurance from April 2029.

Leader of the Council Announces Retirement

After 12 years as Leader of Milton Keynes City Council, Councillor Pete Marland has announced that he will be stepping down from the role and will not stand for re-election as a councillor in May 2026.

Councillor Marland has represented Wolverton Ward since he was first elected in May 2011, becoming leader in May 2014.
